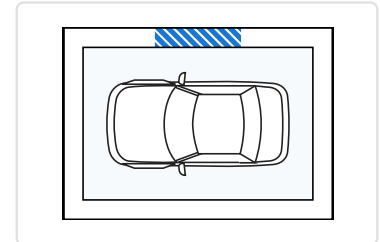

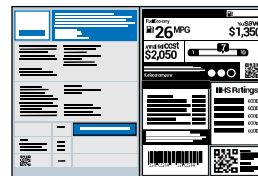

Description: The shifter cable bushing on the transmission end of the shifter cable which can deteriorate and become detached from the transmission. This condition can result in the inability of the driver to actually shift the transmission, even though the driver may move the shifter handle.

If shifter cable becomes detached from the transmission the vehicle may not perform the shifts intended by the driver. Unintended vehicle movement and vehicle crash can occur.

Remedy: Replace the transmission shift cable bushing on the transmission end of the shifter cable.
