DESCRIPTION

The land embraced in the annexed plat of Peter Dupuis' Addition, Carrollton Township, Saginaw County, Michigan, is described as follows: Beginning at a point where the easterly line of Madison St. intersects the northerly line of Hickory St. according to the "Map of Carrollton," a recorded plat of the Village of Carrollton, and running thence N 34° W 66.0 along the northerly line of Hickory St., thence N 55° 56' E 70.78, thence N 34° W 120, thence S 58° 55' W 70.78 to the northerly line of said Hickory St., thence N 34° W 446 along said northerly line of Hickory St., thence N 88° 09' E 118.82, thence S 33° 02' E 130, thence N 56° 09' E 343.0, thence S 33° 53' E 522.0, thence S 65° 35' W 462.69 to the point of beginning.

SURVEYOR'S CERTIFICATE
