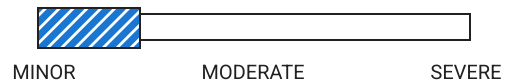

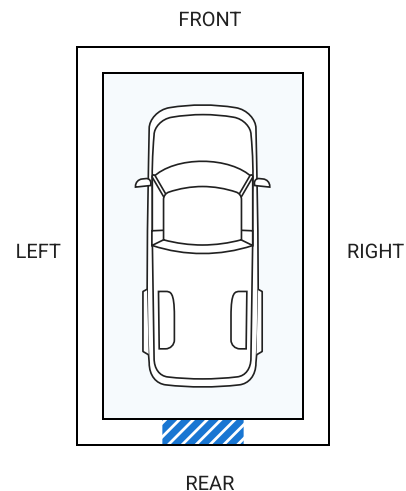

Glossary

Damage Severity
