




Description: General Motors notified the agency that the defective ignition switches may have been used as service replacement parts on other vehicles, and as a result General Motors is recalling certain model year 2008-2010 Chevrolet Cobalt, Saturn Sky, and Pontiac G5 and Solstice, and 2008-2011 Chevrolet HHR vehicles. The part numbers for the service parts are 10392423 (a/k/a ACDelco D1461F), 10392737, 15857948, 15854953, 15896640, and 25846762.

If the key is not in the run position, the air bags may not deploy if the vehicle is involved in a crash, increasing the risk of injury.

Description: General Motors is recalling certain model year 2005-2010 Chevrolet Cobalt, 2006-2011 Chevrolet HHR, 2007-2010 Pontiac G5, 2006-2010 Pontiac Solstice, 2003-2007 Saturn Ion, and 2007-2010 Saturn Sky vehicles. In the affected vehicles, the key can be removed from the ignition when the ignition is not in the "Off" position.

If the key can be removed from the ignition when the ignition is not in the "off" position, the vehicle could roll away: (a) for an automatic transmission, if the transmission is not in the "Park" position; or (b) for a manual transmission, if the parking brake is not engaged and the transmission is not in the "Reverse" position. This potential for rollaway increases the risk for a crash and occupant or pedestrian injuries.

Description: General Motors has decided that a defect, which relates to motor vehicle safety, exists in some 2009-2010 model year Chevrolet HHR (non-turbo), some 2010 model year Chevrolet Cobalt, all 2004-2007 model year Saturn ION vehicles equipped with electric power steering (EPS), and service parts installed into vehicles under safety recall 10023 (10V073) prior to May 31, 2010. The subject vehicles equipped with EPS may experience a sudden loss of power steering assist that could occur at any time while driving.

If the power steering assist is lost, a message is displayed on the Driver Information Center and a chime sounds to inform the driver. Steering control can be maintained, as the vehicle will revert to a manual steering mode, but would require greater driver effort at low vehicle speeds, which could result in an increased risk of a crash.

Remedy: Dealers are to replace the power steering motor free of charge.
