Glossary

Accident Indicator

Failed Emissions Inspection

First Owner

When the first owner(s) obtains a title from a Department of Motor Vehicles as proof of ownership.

Inspections

Many states or counties require annual or biennial emissions and/or safety inspections. Odometer readings are collected at the time of the inspection.

Manufacturer Recall

Automobile manufacturers issue recall notices to inform vehicle owners of a safety defect or failure to meet minimum federal safety or emissions standards. Manufacturer recalls are repaired at no cost to the customer.

New Owner Reported

When a vehicle is sold to a new owner, the Title must be transferred to the new owner(s) at a Department of Motor Vehicles.

Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico.
