
















**Description:** A loose or detached DAB emblem may result in either the emblem or retainers, or both, not remaining attached to the DAB cover during DAB deployment.

A loose or detached emblem or emblem retainer can become a potential projectile during a crash with DAB deployment, which may result in occupant injury.

**Remedy:** The interim repair is to remove the emblem and the emblem retainers from the driver airbag. The final repair is to apply tape to the back of the cover if the emblem is securely attached to the cover. If the emblem is not securely attached, the final remedy is to replace the DAB cover.

**Mileage Inconsistency**

If an odometer reading is less than a previous reading but CARFAX is uncertain whether the discrepancy is a rollback or a clerical error, then CARFAX calls it a "Mileage Inconsistency". In this case, you should verify the mileage with your dealer or a qualified mechanic.

**New Owner Reported**

When a vehicle is sold to a new owner, the Title must be transferred to the new owner(s) at a Department of Motor Vehicles.

**Ownership History**

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico.
