


**Description:** FMVSS No. 111 S5.5.6 requires that the rear visibility system default to the rearview image being visible, and meet the requirements of FMVSS No. 111 S5.5.1 (field of view) and S5.5.2 (image size), at the beginning of each backing event, regardless of any modifications to the field of view that the driver had previously selected. Suspect vehicles are equipped with a "stealth mode" that disables the rearview image when selected and the system does not default to displaying the rearview image at the beginning of the next backing event after being engaged.

The vehicle operator will notice that the rearview image is not displayed if attempting to reference the image while backing. Backing without verifying it is safe to do so could lead to an increased risk of injury to people outside the vehicle.

**Remedy:** Update body control module software to disable stealth mode when the vehicle is shifted into REVERSE.



## **CARFAX** Glossary

#### **Accident Indicator**

CARFAX receives information about accidents in all 50 states, the District of Columbia and Canada.

#### **Damage Severity**
