

Description: American Honda Motor Co., Inc. (Acura) is recalling certain model year 2001-2002 3.2CL, 2000-2003 3.5RL, 2000-2001 3.2TL, and 2001-2002 MDX vehicles. These vehicles may have received a replacement driver frontal airbag module as part of a vehicle repair. Due to a manufacturing issue, the replacement NADI inflator may absorb moisture, causing the inflator to rupture or the airbag cushion to underinflate.

In the event of a crash necessitating airbag deployment, an inflator rupture may result in metal fragments striking the driver or other occupants. An underinflated airbag cushion may not properly protect the occupant. These scenarios increase the risk of serious injury or death.

Remedy: Please call any authorized Acura dealer and make an appointment to have the driver frontal airbag inflator inspected and, if necessary, replaced with an inflator of a different design for free. Manufacturer Recall
