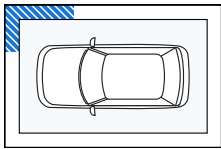

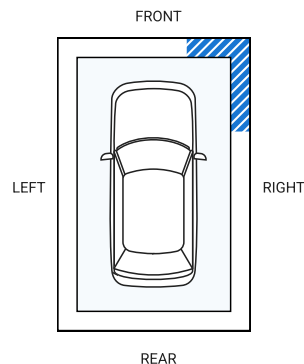

Glossary

Accident Indicator

Damage Severity
