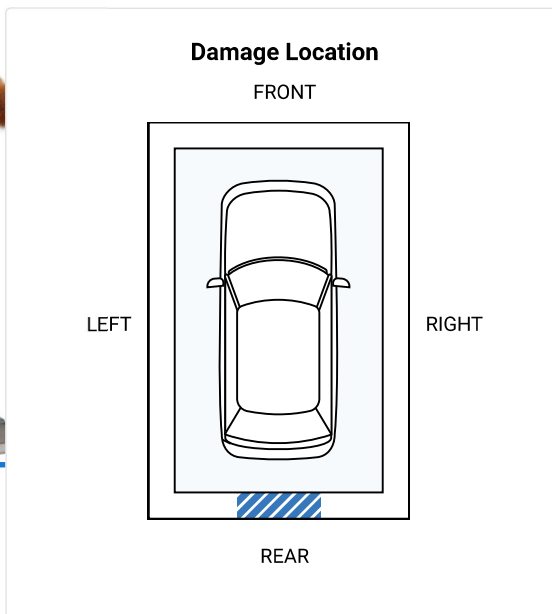
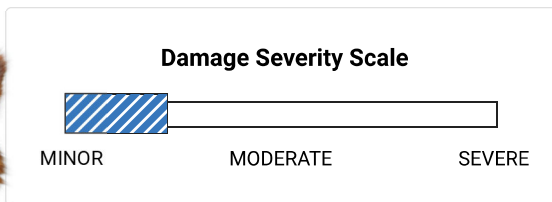

Glossary

Accident Indicator
