



DURING THAT REPAIR, YOUR VEHICLES DOOR LATCHES WERE TO BE REPLACED TO HELP REDUCE THE RISK OF DOORS NOT CLOSING OR DOORS OPENING WHILE DRIVING. IT IS POSSIBLE THAT ONE OR MORE OF YOUR DOOR LATCHES WAS NOT REPLACED OR MAY NOT HAVE BEEN REPLACED CORRECTLY.

IF A DOOR LATCH WAS NOT REPLACED, THERE IS STILL A RISK THAT THE PAWL SPRING TAB INSIDE THE DOOR LATCH COULD BREAK. THIS CONDITION WILL TYPICALLY PREVENT THE DOOR FROM LATCHING.
