Description: THE HEADLAMPS USED FOR PRODUCTION VEHICLES ALLOW FOR HORIZONTAL ADJUSTMENT DURING THE VEHICLE ASSEMBLY PROCESS, BUT THE ADJUSTMENT IS SEALED AFTER THE HEADLAMPS ARE INSTALLED SO THAT NO FURTHER ADJUSTMENTS CAN BE MADE. THESE HEADLAMPS WERE MISTAKENLY SHIPPED TO DEALERS AS A SERVICE PART WITHOUT FIRST DISABLING THE ADJUSTMENT FEATURE.

WITHOUT THE HORIZONTAL ADJUSTMENT MECHANISM DISABLED, THE HEADLIGHT CAN BE ADJUSTED TO EITHER REDUCE THE DRIVER'S VISIBILITY OR BLIND ONCOMING TRAFFIC. BOTH CONDITIONS INCREASE THE RISK OF A CRASH AND CAN OCCUR WITHOUT PRIOR WARNING.



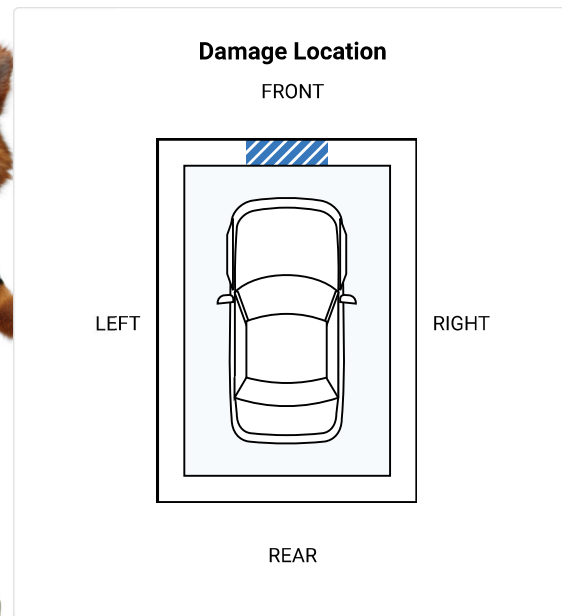

Ownership History
